NOTICE of REMOVAL of UNMARKED WATERCRAFT from ASSOCIATION PROPERTY

Indian Lake residents:

It has come to the attention of the board that there are a number of unmarked boats that are beached or docked on Indian Lake common property. Some of these are in a poor state of repair and are an eyesore and safety hazard. As they are unmarked with Indian Lake lot numbers, the board has no way of knowing who they belong to or whether they are abandoned. Some of these boats may not even belong to Indian Lake residents.

Accordingly, the board of directors has instituted a policy of removing all unmarked watercraft from Indian Lake property and disposing of them as it sees fit.

What do I need to do?

If you own or operate a boat on Indian Lake, you need to mark it with your lot number. Use an indelible marker, paint or decals, and mark it clearly on the bow in 2-inch or larger numbers.

What if I don't mark my boat?

Any unmarked boats or watercraft that are found beached or docked on Indian Lake common property (North Beach, South Beach, docks on easements, etc.) are subject to removal by the ILIA board of directors. Unmarked boats will be tagged with a courtesy notice, giving the owner thirty days to mark or remove the boat. After the thirty days, boats will be removed and subject to disposal or sale.
