Westminster Village North Litigation Settled


I'm pleased to report that on April 17, we settled our lawsuit with Wurster Construction for \$220,000. Wurster was the contractor for the \$25 million Westminster Village North expansion project that broke ground in 2003.

This project was a textbook case of poor erosion control practices. Our expert estimated that 5,400 tons of soil unnecessarily left the WVN job site into Indian Creek, eventually settling into Indian Lake. The lawsuit targeted the many contractors and their subs involved with the project.

We filed our lawsuit in 2009, and spent many hundreds of hours providing and examining documents, answering interrogatories, working with expert witnesses, obtaining estimates from outside dredging and excavating contractors, testifying in and taking depositions, and defending against motions for summary judgment.

To give a taste of how many documents were produced, the photo shows the binder that we handed out to each of the jurors. The binder from the defendants was almost as thick.

Indian Lake hides traces of history

Geast Lake isn't the only artificial lake in Lawrence Township.

About the time the Indianapolis Water Co. began purchasing land for its reservoir, another, smaller body of water was being planned — Indian Lake.

Indian Creek, as noted in the 1880s, had its origins in the swamps of Hancock County. The creek enters Lawrence Township a mile north of the southeast corner and snakes in the general direction of the northwest for several miles before emptying into Fall Creek about three-quarters of a mile northeast of the center of the township.

The first settler in Lawrence Township, Elisha Reddick, named the creek for the American Indians he found encamped along it. Reddick had invited the people living along Indian Creek to help raise his cabin soon after his arrival in the township in October 1823. When the appointed day came only three women came. Elisha sent them to cooking and he instead sought the help of three land prospectors who

were passing through.

A map of Lawrence Township, dating to 1889, shows Paul Klepfer as the owner of some 126 acres encompassing Indian Creek between what is now Sunnyside and Oaklandon roads.

In 1927, the Northern Investment Co. of Indianapolis began acquiring land in the Indian Creek area — roughly north of 63rd Street, south of 79th, east of Sunny-

side Road and west of Oaklandon Road. Northern Investment was formed in 1913 with Mark Rinehart as president and Florence S. Kirkwood as secretary. The company listed among its business activities buying, holding, owning, mortgaging, leasing and selling real estate and personal property.

In 1928, the property was transferred to Indian Lake Development Co., which was incorporated that

year to buy, improve, develop and sell real estate. This included 167 acres valued at \$95,000.

Platting of Indian Lake began in 1929, with three sections totaling 197 lots. Less clear is the date when the dam was built and the lake filled. It must have been about that time because conditions and restrictions to the lots in the three subdivisions were adopted May 16, 1929, including the "lake known as Indian Lake, an artificial body of water created by damming Indian Creek."

Development of the lake was hindered in 1932 when the mortgage of the Indian Lake Development Co. was foreclosed and the company filed bankruptcy.


Still, the property was eventually sold. Vacation-like homes of many shapes and sizes occupy the land. Narrow drives wind up and down, turning sharply as they follow the outline of the shore. The placid lake hides all traces of the land where Reddick sought help to raise his cabin more than 100 years earlier.



Dock in Disrepair?

Is your dock in disrepair after the long winter? Docks in poor repair create safety hazards and are an eyesore. Property owners are responsible for the upkeep of their personal docks and any non-beach common property docks they constructed or use.

The board requests that dock owners promptly repair or remove their unsound docks. There are a number of docks around the lake that are falling apart, and need to be removed. If anyone has difficulty complying with this request, contact a board member and we'll work with you to help remove a dilapidated dock.



Indian Lake Projects Targeting Grant Support for Water Quality

Two Indian Lake residents applied for grants that support water quality related projects through the Fall Creek Watershed Partnership (FCWP) and the Upper White River Watershed Alliance (UWRWA). These organizations have cost-share programs to help landowners reduce nonpoint sources of pollution to our waters through a variety of conservation projects like streambank stabilization, water edge enhancements, filter strips, invasive plant removal, rain gardens and bioswales.

Lynn Osborn and Bill Asher's project, Indian Creek Streambank Stabilization, has been approved for funding and involves removal of Asian bush honeysuckle, the addition of live fascines/coir logs, and seeding of native species along the creek shoreline. The main benefit of the project will be sediment reduction. The UWRWA grant will reimburse 75 percent of the costs of this project, the remainder to be paid by the homeowner.

Ron Gillum's project, Mohawk Drive Rain Garden, was submitted for review this month and involves creating a shallow, 8 inch depressed garden of native flowers and grasses to intercept storm water runoff from impervious surfaces (road, driveway, and roof) before it washes pollutants to the ravine and the lake. This FCWP grant, if awarded, will reimburse 50 percent of the costs of this project, the remainder to be covered by the landowner.

Congratulations to Lynn and Bill on their grant award and good luck to Ron on his application!


Across The Fence

President's message continued...

On April 14, our trial date arrived. The trial was to have been five days, but the court realized that Good Friday was a court holiday and asked that we condense the proceedings to four days. A six member jury was selected on Monday morning, and witnesses for the plaintiff began testifying. Witnesses for the plaintiff were myself and Andy Van Treese from ILIA, Glenn Lange from Marion County Soil & Water, Rob Beck from IDEM, and Greg Bright from Commonwealth Biomonitoring. On Wednesday, we rested our case, and witnesses for the defense began testifying.

On Thursday morning, the Wurster corporate attorney approached us to discuss the possibility of settling the case. At this point we knew that the jury was very engaged, but neither us nor the defendants could tell which direction they were leaning. We weren't able to reach a mutually agreeable settlement figure, so the trial proceeded. After another witness testified, we were again approached about settling. This time, we were able to agree on a figure, \$220,000.

After the judge dismissed the case, we had the chance to interview the jury, and learned which witnesses were most effective. The jury especially liked "the golf-ball

guy" A.K.A. Andy Van Treese explaining how golf balls from miles up the creek could actually travel all the way to Indian Lake.

Thanks to our watershed watchdogs who provided key photos for the case, our excellent attorneys at Plews, Shadley, Racher & Braun, and all our witnesses. After expenses and attorney fees, this settlement will allow us to mitigate a significant amount of sediment.

The annual meeting was held on January 29 at the Jenn Park pavilion and was well attended. We got to hear the Mayor's "state of the city," discuss what's going on in our neighborhood, and enjoy some tasty hot food.
